<b>Job Title:</b>	KS1 Teacher
<b>Line Manager:</b>	Head of Prep Prep

### Primary Responsibilities:

To create a happy, stimulating atmosphere in the classroom so that children feel at ease in their surroundings and prepared to take an active part in what is going on.

To develop appropriate social skills and promote positive behaviour.

To follow a planned curriculum that will encourage children to develop physically, intellectually, socially and emotionally, both indoors and outdoors.

To make sure each child progresses at a rate in line with his or her ability.

To respond positively to children's efforts, to praise their achievements and encourage individual progress.

To encourage children to be enquiring, to put their own effort into learning and so gain a true sense of achievement.

To ensure the approach to discipline is firm but kind.

To welcome parents into the classroom and try to understand each child's development in the context of his or her family.

To be accessible to parents during term time so that they can be guided on and reassured about their child's progress.

To teach the class the main academic subjects, i.e. Mathematics, English, Science, History, Geography, Religious Education, Information and Communication Technology, and through these establish the basic skills of reading, writing and number.

To provide opportunities for the children to enjoy creative activities, i.e. Art, Design and Technology, Drama, Music and PSHEE.

To plan, with the parallel teacher/s, an appropriate curriculum differentiated for all abilities.

To meet colleagues each week to discuss and appraise what is being achieved and to plan ahead.

To follow units of study which have been laid down for the year and to review these regularly with the Subject Co-ordinators and Head of Subject.

To encourage the children to develop physical skills by working with specialist PE staff and taking part in physical activities and sporting events.

To create a lively, stimulating classroom environment through relevant displays of children's work.

To arrange and go on topical educational visits with the class when these enhance the children's learning and complete all the necessary paperwork using the school's trip pack.

To keep a record of lessons planned and taught through each term.

To mark the children's work thoroughly and systematically (see Marking Policy).

To keep records of individual academic progress in core subjects – bearing in mind the relevant attainment targets for the age group. Social and emotional development should also be recorded appropriately.

To be prepared to take on the role of a KS1 Subject Coordinator should the post arise and work with the Head of Subject and Head of Years 1 & 2 to oversee the planning, teaching and learning of this subject in KS1

To organise and direct a Class Assembly (in Year 1) or a year group play (in Year 2) with the parallel teachers annually

To prepare and lead a Year 1 and 2 assembly each term.

To organise and attend Parents' Evenings (including Curriculum Evening in September and a Saturday Open day, typically in the Autumn Term).

To direct and guide support staff in their work with children.

### **Extra-Curricular Activities**

Staff are expected to offer an extra-curricular activity (e.g. a club) each term, although this offer will not always be taken up, depending on the term's overall extra-curricular programme.

### **Key Stage One Subject Co-Ordinator**

To act as a Key Stage One Subject Co-ordinator (or possibly Whole School Head of Subject) for a subject if requested to do so. A separate financial allowance is paid for this.

To make sure each child progresses at a rate that is fair to expect.

## **Areas of Responsibility**

To teach the class the main academic subjects i.e. Mathematics, English, Class Science, PSHEE (Learning for Life), History, Geography and Computer Studies or a specified Specialised Subject.

To follow schemes of work which have been laid down for the year and to review these regularly.

To encourage opportunities for the children to enjoy creative activities in and out of the classroom, i.e. Art, Design and Technology, Drama and Music.

To create a lively, stimulating classroom through relevant displays of children's work.

To keep a record of lessons planned and taught through each term bearing in mind the aims and expectations of the National Curriculum.

To mark the children's recorded work thoroughly and systematically (see Marking Policy).

To keep records of individual progress in core subjects, geography and history.

To meet with colleagues each week to discuss and appraise what is being achieved and to plan ahead.

To arrange and go on educational visits with the class when these are relevant to the class work.

To write individual reports on each child twice in the year.

To be accessible to parents during term time so that they can be guided on and reassured about their child's progress.

To organise and be present at Parents' Evenings, to be at the Open Mornings and Parents' Afternoons.

To attend in-service training days whenever they are held in school.

To attend Staff, Section and Subject Meetings when they are held.

To be prepared to go on day and residential courses if they are relevant to the work being covered in school.

To look after the pastoral/social welfare of each pupil.

To do extra duties as directed by the Deputy Head, e.g. Lunch or playground duties and/or After School Care.

To either organise Class Assemblies or help with the annual Year Group Play.

To take Section Assemblies when required.

## Benefits

### **Salary:**

The Manor has its own salary scale. Employees' starting salary will depend on the experience and qualifications of the successful candidate. The Governors review salary scales each year to ensure they remain competitive. Annual salary is paid in 12 equal payments by bank transfer on the 30<sup>th</sup> / 31<sup>st</sup> of every month, or the last working day of the month if the 30<sup>th</sup> / 31<sup>st</sup> falls on a weekend.

### **Pension:**

For teaching staff the Pension Scheme is with Aviva Pension Trust for Independent Schools (APTIS) with 6% employer contribution. There is a further 10% flexible pay option the school will contribute and Teaching staff are asked to decide the split between additional pension contribution and additional non-pensionable pay.

## **Non-contractual Benefits**

**Lunch, Drinks and Snacks:** Staff are provided, at no cost, with lunch, hot drinks and snacks throughout the day (term time only).

## **Application and Recruitment Process**

### **Application Form**

- Applications will only be accepted from candidates completing the enclosed application form in full. CV's will not be accepted in substitution for completed application forms. They may, however, be submitted in addition to the application form.
- Candidates should be aware that all posts in the School involve some degree of responsibility for safeguarding children, although the extent of that responsibility will vary according to the nature of the post. Please see the job description [and person specification] for the post.
- The successful applicant will be required to complete a disclosure form from the Disclosure and Barring Service (DBS) for the post and, where appropriate, a check of the Barred List maintained by the DBS will be made. Any offers of appointment will be made conditional on obtaining such satisfactory checks. For further information, please contact the Disclosure and Barring Service – <https://www.gov.uk/government/organisations/disclosure-and-barring-service> - Additionally, successful applicants should be aware that they are required to notify the School immediately if there are any reasons why they should not be working with children.
- The School takes its responsibility to safeguard children very seriously and any staff member and/or successful candidate who is aware of anything that may affect his/her suitability to work with children must notify the School immediately. This will include notification of any convictions, cautions, court orders, reprimands or warnings he/she may receive.
- The Childcare (Disqualification) and Childcare (Early Years Provision Free of Charge) (Extended Entitlement) (Amendment) Regulations 2018 apply to those providing early years childcare or later years' childcare, including before school and after school clubs, to children who have not attained the age of 8 and to those who are directly concerned in the management of that childcare.
- Staff and/or successful candidates who are disqualified from childcare or registration may apply to Ofsted for a waiver of disqualification. Such individuals may not be employed in the areas from which they are disqualified, or involved in the management of those settings, unless and until such waiver is confirmed. - The School has a legal duty under section 26 of the Counter-Terrorism and Security Act 2015 to have 'due regard to the need to prevent people from being drawn into terrorism'. This is known as the Prevent duty. Schools are required to assess the risk of children being drawn into terrorism, including support for extremist ideas that are part of terrorist ideology. Accordingly, as part of the recruitment process, when an offer is made the offer will be subject to a Prevent duty risk assessment.
- We will seek references on shortlisted candidates and may approach previous employers for information to verify particular experience or qualifications, before interview.
- If you are currently working with children, on either a paid or voluntary basis, your current employer will be asked about disciplinary offences, including disciplinary offences relating to children or young persons (whether the disciplinary sanction is current or time expired), and whether you have been the subject of any child protection allegations or concerns and, if so, the outcome of any enquiry or disciplinary procedure.
- If you are not currently working with children but have done so in the past, that previous employer will be asked about those issues. Where neither your current nor previous employment has involved working with children, your current employer will still be asked about your suitability to work with children. The employer may answer 'not applicable' if your duties have not brought you into contact with children or young persons.



The school may contact any of your previous places of work, whether or not they have been named in connection with a referee. Where you have no previous employment history, we may request character references which may include references from your school or university.

- As the job for which you are applying involves substantial opportunity for access to children, it is important that you provide us with accurate answers. You should be aware that provision of false information is an offence and could result in the application being rejected or summary dismissal if the applicant has been selected and possible referral to the police and/or DBS.

### **Invitation to Interview**

Please note, interviews may take place remotely if Covid restrictions apply.

#### What to bring to the interview

All candidates invited to interview must also bring with them:

1. A current driving licence including a photograph and paper counterpart or a passport or a full birth certificate;
2. A utility bill or financial statement issued within the last three months showing the candidate's current name and address;
3. Where appropriate, any documentation evidencing a change of name;
4. Where applicable, proof of entitlement to work and reside in the UK. Further information regarding the necessary documentary evidence can be found on the Home Office website. Please note that originals of the above are necessary. Photocopies or certified copies are not sufficient.

5. All candidates invited to interview must bring documents confirming any educational and professional qualifications that are necessary or relevant for the post (e.g. the original or certified copy of certificates, diplomas etc). Where originals or certified copies are not available for the successful candidate, written confirmation of the relevant qualifications must be obtained by you from the awarding body.
6. If the position you are applying for requires a mandatory professional qualification or membership you will need to produce your qualification and proof of professional membership at interview.

#### Disability and reasonable adjustments

Candidates with a disability who are invited to interview should kindly inform the School of any necessary reasonable adjustments or arrangements to assist them in attending the interview.

### **Conditional Offer of Appointment: Pre-Appointment Checks**

Any offer to a successful candidate will be conditional upon

- verification of identity and qualifications
- verification of right to work in the UK, where appropriate
- a satisfactory Enhanced DBS check and, if appropriate, a check against the Children's Barred List and the Adults' Barred List maintained by the DBS
- Where the successful candidate has worked or been resident overseas (including EEA teaching candidates), such checks and confirmations as the School may consider appropriate so that any relevant events that occurred outside the UK can be considered.



This shall include the candidate providing the School with proof of his/her past conduct as a teacher in the form of a letter of professional standing from the professional regulating authority in the country in which s/he has worked

- receipt of at least two satisfactory references (if these have not already been received), including for internal appointments. All references should be provided by a senior person with appropriate authority, subject to the satisfaction of the School
- verification of professional status such as GTC registration, QTS Status (where required), NPQH
- evidence of satisfactory medical fitness
- Receipt of a signed Staff Suitability Declaration form showing that the candidate is not disqualified from providing childcare as set out in the statutory guidance "Disqualification under the Childcare Act 2006 (July 2018)"
- satisfactory completion of the probationary period
- verification of successful completion of statutory induction period (applies to those who obtained QTS after 7 May 1999), where relevant

The School is aware of its duties under the Equality Act 2010. No job offer will be withdrawn without first consulting with the applicant, considering medical evidence and considering reasonable adjustments.

## References

We will seek the references referred to above for all shortlisted candidates, including internal candidates and may approach previous employers for information to verify particular experience or qualifications, before interview. If you do not wish us to take up references in advance of the interview, please notify us at the time of submitting your application.

For internal candidates, formal written references may be sought from a senior person with appropriate authority.

All referees will be asked if the candidate is suitable to work with children.

The School will compare any information provided by the referee with that provided by the candidate on the application form. Any inconsistencies will be discussed with the candidate.

## **Criminal Records Policy**

The School will refer to the Department for Education (“DfE”) document, ‘Keeping Children Safe in Education’ and any amended version in carrying out the necessary required DBS checks.

The School complies with the provisions of the DBS Code of Practice, a copy of which may be obtained on request or accessed here: <https://www.gov.uk/government/publications/dbs-code-of-practice>.

Any offer of employment is conditional upon the School obtaining an Enhanced Disclosure from the Disclosure and Barring Service (DBS) which the School considers to be satisfactory. The School applies for an Enhanced check for Regulated Activity from the DBS (which includes a check of the Children’s Barred List) in respect to all positions at the School which amount to regulated activity. It is unlawful for the School to employ anyone who is barred from working with children. It is a criminal offence for any person who is barred from working with children to attempt to apply for a position at the School. If you are successful in your application, you will be required to complete an online DBS Disclosure Application Form. Any information disclosed will be handled in accordance with any guidance and/or Code of Practice published by the DBS.

## **Policy on the Recruitment of Ex-Offenders**

Instead, each case will be fairly and objectively assessed by the School in relation to the nature of the employment applied for, and the nature of the offence concerned.

Any member of staff, their family (if over 16), volunteer, agency/contract staff working at the school or any other adult coming into regular contact with the children or having unsupervised access to school premises, will not be employed or permitted to live or work on school premises if recruitment checks disclose that they have been convicted of an offence which indicate that they may be unsuitable to work with or have regular contact with children.

Under the relevant legislation, it is unlawful for the School to employ anyone who is included on the lists maintained by the DBS of individuals who are considered unsuitable to work with children. In addition, it will also be unlawful for the School to employ anyone who is the subject of a disqualifying order made on being convicted or charged with the following offences against children: murder, manslaughter, rape, other serious sexual offences, grievous bodily harm or other serious acts of violence. It is also unlawful for the School to knowingly employ someone who works in the relevant settings and is disqualified from providing childcare under the statutory guidance “Disqualification under the Childcare Act 2006 (July 2018)”.



It is a criminal offence for any person who is disqualified from working with children to attempt to apply for a position within the School. The School will report the matter to the Police and/or the DBS if:

- the School receives an application from a disqualified person;
- is provided with false information in, or in support of, an applicant's application; or
- the School has serious concerns about an applicant's suitability to work with children.

Please note that any employer (where children are involved), whom we contact for a reference, will be asked to declare if you have been subject to any substantiated allegations or concerns, as defined by the Department of Education, that have been raised (whether formally or informally) about you relating to the safety and welfare of children and young people, and if so, the outcome.

All candidates should be aware that provision of false information is an offence and could result in the application being rejected or summary dismissal if they have been appointed, and a possible referral to the police and/or DBS.

In the event that relevant information (whether in relation to previous convictions or otherwise) is volunteered by an applicant during the recruitment process or obtained through a disclosure check, the School will consider the following factors before reaching a recruitment decision:

- whether the conviction or other matter revealed is relevant to the position in question;
- whether the conviction or caution is 'protected' as defined by the Rehabilitation of Offenders Act 1974 (Exceptions) Order 1975 (Amendment) (England and Wales) Order 2020 (if yes, it will not be taken into account);
- the seriousness of any offence or other matter revealed;
- the length of time since the offence or other matter occurred;
- whether the applicant has a pattern of offending behaviour or other relevant matters;
- whether the applicant's circumstances have changed since the offending behaviour or other relevant matters;
- in the case of disqualification from providing childcare, whether the applicant has or is able to obtain an Ofsted waiver from disqualification; and
- the circumstances surrounding the offence and the explanation(s) offered by the convicted person.

If the post involves regular contact with children, it is the School's normal policy to consider it a high risk to employ anyone who has been convicted at any time of any the following offences: murder, manslaughter, rape, other serious sexual offences, grievous bodily harm or other serious acts of violence, serious class A drug related offences, robbery, burglary, theft, deception or fraud.

If the post involves access to money or budget responsibility, it is the School's normal policy to consider it a high risk to employ anyone who has been convicted at any time of robbery, burglary, theft, deception or fraud. If the post involves some driving responsibilities, it is the School's normal policy to consider it a high risk to employ anyone who has been convicted of drink driving.

### **Retention and Security of Records and Data Protection**

The School will comply with its obligations regarding the retention and security of records in accordance with the DBS Code of Practice and its obligations under its Data Protection Policy. Copies of DBS certificates will not be retained for longer than 6 months. Details of how we use candidates' data is explained in the Recruitment Privacy Notice and Data Protection Policy.
